#### 13/145 Allotments and conservation area

The councillors reviewed the draft leases for the conservation and allotments areas drawn up by Babergh District Council. The Clerk was asked to raise the councillors' comments on the leases in the following areas:

- Both Leases should contain a condition that the Landlord contacts the Tenant when the lease has one year to run before expiry
- Both leases should have the option to terminate the lease with 12 months' notice on or after the 29<sup>th</sup> September in any year but there should be an initial 5 year period where this is not an option. With the set-up costs of both areas the councillors do not want to have to move in the first 5 years.
- Section 3.3 Maintenance of the conservation lease to be modified in light of planned use of the area and Section 3.6 Closing of Property to be deleted.
- Section 3.9 of the allotments lease to be worded on the basis that there will be a wire fence around the allotments to keep out rabbits etc.
- The conservation lease to start in Spring 2014 and the allotments lease to commence upon the completion of the affordable housing scheme.
