# 17/075 Minutes of Meeting held on 22<sup>nd</sup> May 2017

The minutes of the meeting were approved and signed by the Chairman as a correct record.

#### 17/076 Public Forum

- a. County Councillor James Finch gave his report appendix A.
- b. District Councillor Jennie Jenkins reported that Babergh DC had introduced pre-planning application charges, these will be cost neutral as they are currently making a loss. The move to Endeavour House is planned for the end of November and they are keen that the building in Hadleigh is not left empty and some of the facilities at the building may still be used.
- c. Residents living close to the Koning site which was previously Copella informed the council of their concerns at proposals to triple the size of the site which they felt was not in keeping with the development within the AONB, increase in HGV traffic which is unable to pass at certain points in the road and more suitable sites are available

## 17/077 Boundary Review

District Councillor Jennie Jenkins informed the council that two proposals to realign the wards are being considered, to include a. Bures St Mary, Assington, Newton and Boxford (2666 residents) or b. Little Cornard, Assington, Leavenheath and Newton (2157 residents). In 2019 district councillors will be reduced from 43 to 31 and the Boundary Commission will have the final decision. It was agreed that the councillors felt they were more aligned with option (a), so that the ward would include Bures St Mary, Assington, Newton and Boxford. The clerk will respond on behalf of the council.

- The additional HGV traffic would disturb the tranquillity in the Dedham Vale AONB and is not suitable for the B1068 which is a rural road and does not have the width in places for HGV's to pass
- The B1068 is not suitable for the increase in traffic as there is already additional traffic using this road which has increased significantly over the years going to Stoke By Nayland Hotel, Golf and Spa
- The size of the development and the increase height of the buildings is not appropriate within the AONB
- b. Planning Application DC/17/02705 Erection of extension following demolition of existing extension at Bramwell House, Colchester Road, Assington, Sudbury Suffolk CO10 5LX was reviewed and supported
- c. Planning Application DC/17/03021 Change of use of existing agricultural building to dwelling and associated building operations at Land at Gedding Hall, Nayland Road, Assington, Sudbury, Suffolk CO10 5LR was reviewed and supported
- d. Planning Application DC/17/03535 Prior Approval Application for conversion to 3 dwellings at Hill Farm, The Street, Assington, Sudbury, Suffolk CO10 5LR. The councillors agreed to object to the application on the grounds that:
  - It is not a barn conversion as it is a recently built grain store and there is a need for agricultural storage in the village
  - There will be additional traffic and poor access
  - The style of the building is not in keeping with the requirements of the village as specified in the village survey which was to fill properties in along the street.
  - Unsuitable within a conservation area

### > The Ipswich Park & Ride Launch 2017

The new Park & Ride commercial service run by First Eastern Counties launch took place on Monday 3 July. The new service will run every 15 minutes from 7am to 7pm, Monday to Saturday. First's proposal has enabled SCC to achieve its proposed saving of £0.5m each year. It is important that we take every opportunity to promote First's Park & Ride service and use it ourselves.

## > Highways Transformation

A new Highways Senior Leadership Team was established with effect from 6 March 2017, with appointments made to all Head of Service roles under Phase 1 of the organisational change process.

Heads of Service have assisted in the finalisation of the new organisational structure for Suffolk Highways, The finalisation of appointments will be made during week commencing 3 July 2017.
