Babergh District Council Annual meeting

Support for **Ukranian refugees** – Babergh District Council has issued 97 local visas Suffolk has issued 772. Community Action Suffolk has a lot of information to provide assistance to anyone wishing to help refugees.

Energy rebate payments £157 has been rebated to everyone paying Council Tax by Direct Debit. People who don't pay by DD have received a letter with instructions to apply for the payment. BDC already have bank account details for DD payers, if anyone needs assistance phone DCIIr Lee Parker
